Minimum Age Requirement on Lifeguard positions: 15 years of age

Minimum Age Requirement on Head Guard: 17 years of age

Lifeguard

Pay Range \$8.50 – \$9.00 Per Hour

1 st Year Guarding	\$8.50
2 + Years Guarding	\$8.75
Lifeguard Certified and WSI Certified	\$9.00

Head Lifeguard

Pay Range \$9.25 – \$9.75 Per Hour

1st Year Head Guarding	\$9.25
2 nd Year Head Guarding	\$9.50
3 + Years Head Guarding	\$9.75

Requirements: Must be a Certified Red Cross Lifeguard or pass Ogden City Red Cross Lifeguard Certification Training program after the initial interview and/or must have a current Red Cross Water Safety Instructor certification. All lifeguards taking the Ogden City Red Cross Lifeguarding Training Program will be required to pay for the Red Cross Lifeguard Certification no later than one week prior to training.

Essential Functions: Works under the direction and supervision of the Swimming Pool Manager. Is responsible for the safety of patrons at the facility and is responsible to provide information pertaining to water quality, temperature, safety conditions, hazards, slide conditions and other related items, and to act as an emergency aid as necessary, always exhibits a professional lifeguard appearance and attitude. Attendance and punctuality are essential functions of this position. Employee is required to work as a team and frequently meet with co-workers and supervisors; employee is required to communicate in-person with the public during office hours; and employee is required to use on-site equipment.

Safeguards and regulates the conduct of patrons to prevent accidents; alert possible patrons in distress and avoids unnecessary conversations with the public or other actions which will distract them from their duties; strictly and tactfully enforces policies, rules, regulations, laws and other ordinances governing pool conduct; effects rescues; performs appropriate follow-up procedures including the use of any available equipment in the performance of first aid; participates in the maintenance and preparation of daily records and tasks relating to rescues, assists, first aid, weather conditions, sanitation, and swimming lessons may be required.

Cost for Ogden City Red Cross lifeguard class is \$100.00 which includes rental of books. ALL APPLICANTS WHO PASS THIS CLASS AND HAVE SUCCESSFUL EMPLOYMENT AT LORIN FARR POOL FOR THE ENTIRE 2021 SEASON WILL BE REIMBURSED THE \$100 FEE.
